PSLF Social Media Toolkit

This document is a social media toolkit for public service employers who are supporting their employees in accessing the federal Public Service Loan Forgiveness program through The California Student Debt Challenge (#CAChallenge). This toolkit provides sample post copy, graphics, hashtags, and social media handles for resources and partners that employers can use to show they are participating in the #CAChallenge and spread information to others.

Campaign Background:

As a participant and supporter of <u>The California Student Debt Challenge</u> (CA Challenge) led by the Campaign for California Borrowers' Rights, College Futures Foundation is helping to spread the word about the Public Service Loan Forgiveness (PSLF) program to help Californians access this federal program, which cancels the remainder of public service workers' federal student loans after ten years of work. An estimated 825,000 Californians qualify to have their student loan debt eventually canceled through PSLF, but only around 10.000 have received cancellation!

This is a great opportunity for more Californians to become debt-free and financially stable—and an important moment for employers to show that they care about their employees' financial well-being.

We're asking public service employers in California to take on the CA Challenge and agree to engage in a number of activities that support their student loan borrower employees by sharing PSLF info and resources to help them check eligibility and apply for loan forgiveness before the deadline on October 31, 2022!
